#### Modern Slavery Act Statement

# Slavery and Human Trafficking Transparency Statement for the financial year ending 31st December 2021

This Statement is made pursuant to Section 54 of the Modern Slavery Act 2015 and sets out the steps that Handicare Accessibility Ltd ('Handicare') is taking to ensure that slavery and human trafficking is not operating within either its own business or its supply chains.

This Statement has been approved and signed by Handicare Accessibility Ltd.'s Board of Directors.

### Handicare's Organisational Structure and Supply Chains

Handicare is a global company owned by Savaria Corporation, Quebec. With manufacturing facilities in Europe, North America and Asia. At Handicare we are committed to making everyday life easier for disabled and elderly people and supporting those who assist them. Our products and solutions include curved and straight stairlifts, transfer, lifting and repositioning aids. We are approximately 940 employees globally. In 2021, revenue totalled MEUR 246.

Handicare sources a wide range of goods and services from suppliers based in the United Kingdom and overseas as described above. In its dealings with those suppliers it strives to ensure that the highest ethical standards are attained at all times. Handicare has close relations with most of the company's suppliers and our assessment is that the risk of human rights violations amongst our suppliers is low. However, as part of Handicare's commitment, there has been an increased focus on the requirement for its suppliers to eradicate slavery and human trafficking in their own businesses and supply chains.

#### Handicare's Policies and Due Diligence

Handicare strives to ensure that it does not contribute towards adverse human rights impacts both internally and through its supply chains. There is an ongoing commitment to engage only those suppliers that uphold the same principles as Handicare and where necessary ensure the implementation of corrective action measures. In the event that suppliers fail to take steps to cease or prevent adverse human rights impacts, Handicare will reconsider its business relationships with those suppliers.

All direct product procurement activity is conducted within the framework of Handicare's purchasing policy, which describes our external policy for suppliers. It includes a Supplier Code of Conduct, which is based on ethical, societal and environmental topics and describes Handicare's expectations in three general areas: anti-corruption and ethics; labour standards and human rights; and environment. In light of the Modern Slavery Act 2015 it was updated in 2017 to include clauses pertaining to modern slavery.

As part of our supplier onboarding process all major suppliers are asked to sign and send back a document confirming they have read, understood and commit to adhere to the revised Group Purchasing Policy.

Supplier audits are carried out now to include a Modern Slavery and Human Trafficking compliance audit.

As part of our wider commitment to promoting ethical business practices Handicare has also adopted a Corporate Compliance Programme which provides a framework for the below overarching policies and details the approach to training of these policies and internal audit.

- Handicare Code of conduct. The Code of Conduct sets forth Handicare's core principals. It
  includes a letter from the board of directors and a description of the Company's stance on key
  issues in three general areas: anti-corruption and ethics, labour standards and human rights and
  the environment.
- Handicare's employee handbook has been updated to include modern slavery awareness in the safeguarding policy and procedure.
- Whistleblowing Policy and Whistleblowing system. Employees have the opportunity to report any misconduct or concerns via an anonymous Whistleblowing service.

#### 2021 Improvement Activities

- In 2021 we extended our awareness training programme to include Supply Chain, Purchasing, Warehouse/Production Supervisors and UK Board
- We organised a poster campaign around our Kingswinford site to ensure the topic and issues surrounding modern slavery are visible to all associates and methods of reporting are clear.
- We also added risk as a criteria for frequency of supplier audits.

#### Continued Due Diligence

- In 2022 we will extend our awareness training programme to include our warehouse and production operatives.
- We will continue our associate awareness programme by adding a modern slavery awareness campaign to our globally distributed e-newsletter (Connect)
- Along with ensuring our Supplier Onboarding process evaluates risk for new suppliers and ensuring our audit programme monitors existing suppliers, we will also carry out awareness presentations to our key suppliers.
